

ORDINANCE NO. 10-2017

Village of Sugar Grove, Fairfield County, Ohio

AN ORDINANCE APPROVING A SUPPLEMENTAL APPROPRIATION AND TRANSFER OF MONIES FROM GENERAL FUND (1000) TO SEWER FUND (5201) FOR FY2017 FOR CURRENT EXPENSES AND OTHER EXPENDITURES, AND DECLARING AN EMERGENCY

WHEREAS, Village appropriations for FY2017 approved on February 27, 2017 in Ordinance 4-2017 are determined to be insufficient to cover necessary expenses for the Village Sewerage system and repayment of debts; and

WHEREAS, the Village Sewer Fund (5201) needs additional revenue to cover necessary expenses for emergency repairs, equipment and repayment of debts; and

WHEREAS, Village Council makes supplemental appropriations to reflect adjustments which occur throughout the fiscal year, and

WHEREAS, the Mayor recommends the passage of this Ordinance as an emergency measure, as it is necessary for the immediate preservation of the public peace, health, safety, and property;

NOW, THEREFORE BE IT ORDAINED by the Council of the Village of Sugar Grove, Fairfield County, State of Ohio as follows:

Section 1. The Fiscal Officer is hereby authorized to make a permanent supplemental appropriation for the General Fund (1000) 1000-910-910-0000 in the amount of \$30,000 and transfer said monies to the Sewer Fund (5201) 5201-931-0000, making permanent supplemental appropriations for the Sewer Fund programs and purposes as follows: \$25,000 to 5201-850-710-0000 "Principal", \$3,000 to 5201-800-520-0000 "Equipment," and \$2,000 5201-549-399-0000 "Other - Other Contractual Services".

Section 2. The Fiscal Officer shall certify this Ordinance to the County Auditor that the supplemental appropriation to the General Fund and subsequent transfer out do not exceed the Official Amended Certificate of Estimated Resources No. 2 for FY2017, which governs the total of appropriations made at any time during the fiscal year.

Section 3. This Ordinance is hereby declared to be an emergency measure and is necessary for the immediate preservation of the public peace, health, and safety of the inhabitants of the Village of Sugar Grove, the necessity for such action arising out of the need for sound financial management of Village affairs.
