

ORDINANCE NO. 11-2017

AN ORDINANCE TO RAISE THE COMPENSATION RATES FOR OFFICERS OF THE VILLAGE OF SUGAR GROVE, FAIRFIELD COUNTY, OHIO

WHEREAS, the Village has not raised the compensation rate for its officers in many years; and

WHEREAS, members of Village Council often spend as much time in their duties in various Council subcommittee meetings as they do in regular Council meetings;

NOW THEREFORE, BE IT ORDAINED by the Council of the Village of Sugar Grove, Fairfield County, Ohio as follows:

Section 1. The compensation per Council meeting for members of Village Council shall be increased to \$50.00 per Council meeting attended. The compensation for Council members attending subcommittee meetings shall be set at \$25.00 per subcommittee meeting attended, up to a maximum of four meetings per year per subcommittee the Council member serves on; and

Section 2. The payment per meeting for members of the Board of Public Affairs (BPA) shall be increased to \$50.00 per meeting attended; and


Section 3. The payment for the Mayor of Sugar Grove shall be raised to \$500.00 per month.

Section 4. Effective Date: The aforementioned increases in compensation shall not take effect for each seat on Council and the BPA during that particular seat's current term of office. The increase shall take effect only after the beginning of the next term for each individual seat. The increase for compensation of the Mayor's monthly rate shall likewise not take effect until the start of the next mayoral term of office following the current term of office.
