

ORDINANCE NO. 12-2017

AN ORDINANCE TO PERMIT THE PARKS COMMITTEE OF VILLAGE COUNCIL FOR SUGAR GROVE, FAIRFIELD COUNTY, OHIO, TO CHARGE FOR THE RENTAL OF PARK PAVILIONS

WHEREAS, the rental of pavilions at the park within Sugar Grove, Fairfield County, Ohio, would serve the Village's financial interests through collection of rental fees; and

WHEREAS, the Village Council Parks Committee regularly manages maintenance of said park, and has indicated willingness to likewise manage rental of park pavilions;

NOW THEREFORE, BE IT ORDAINED by the Council of the Village of Sugar Grove, Fairfield County, Ohio as follows:

Section 1. The Village of Sugar Grove does authorize charging non-Village residents for the rental of park pavilions at the rate of \$25.00 for the first four (4) hours of rental, and \$50.00 for an all-day rental. Either rental shall require a \$25.00 deposit.

Section 2. The scheduling, fee collection, and general management of park pavilion rental shall be the responsibility of the Chair of the Parks Committee, or such other responsible individuals the Chair may delegate such duties to.


Section 3. All fees collected for park pavilion rental shall be remitted to Village Special Revenue Fund 2041.

Section 4. Rental of Park pavilions shall remain free to Village residents, but permission to reserve a pavilion must still be made through the Chair of the Parks Committee.


