

Ordinance NO. 14-2017
Village of Sugar Grove, Fairfield County, Ohio

AN ORDINANCE TO CREATE AND POST A 15 MILE PER HOUR SPEED LIMIT ZONE FOR TWO ALLEYS IN THE VILLAGE OF SUGAR GROVE, OHIO, AND DECLARING AN EMERGENCY

WHEREAS, it is necessary for the safety of Village residents and drivers to require appropriate limits on vehicular speed; and

WHEREAS, alleyways in the Village necessitate low levels of speed consistent with the 15 mile per hour limit permitted for Alleys in the Ohio Revised Code;

WHEREAS, the Mayor recommends the passage of this Resolution as an emergency measure, as it is necessary for the immediate preservation of the public peace, health, safety, and property, to-wit: the safety of Village residents and property from excessively fast driving;

NOW THEREFORE, BE IT ORDAINED by the Council of the Village of Sugar Grove, Fairfield County, Ohio as follows:

Section 1. The Village of Sugar Grove does authorized the posting of signs for the below-described alleys prohibiting vehicular traffic in excess of fifteen (15) miles per hour.

Section 2. The first alley to be so posted, hereafter referred to as "Middle Alley", is the alleyway permitting two-way traffic running north/south beginning at West Fifth Street to West First Street.

Section 3. The second alley to be so posted, hereafter referred to as "Center Alley", is the alleyway running one way north from South Main Street to East Fifth Street.


Section 4. Violations of said posted speed limits shall be prosecuted as per violations of Speeding ordinances under the Village Code. Enforcement shall begin immediately upon the posting of signs in said alleys

Section 5. This Ordinance is hereby declared to be an emergency measure and is necessary for the immediate preservation of the public peace, health, and safety of the inhabitants of the Village of Sugar Grove, to wit: the safety of Village residents and property from excessively fast driving.



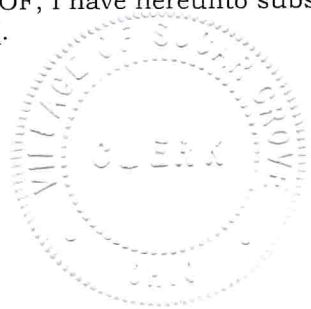
