

Ordinance NO. 15-2017
Village of Sugar Grove, Fairfield County, Ohio

AN ORDINANCE TO CREATE THE NEW SUGAR GROVE POLICE DEPARTMENT RANK AND PAY RATE FOR SERGEANT, AND DECLARING AN EMERGENCY.

WHEREAS, the Chief of the Sugar Grove Police Department has stated a recommendation to create the new rank of Sergeant with a pay rate of \$10.75 per hour; and

WHEREAS, the Chief of Police has heartily recommended filling the new Sergeant position as of August 14, 2017, by the promotion of Officer Jason Costlow; and

WHEREAS, the Mayor recommends the passage of this Ordinance as an emergency measure, as it is necessary for the immediate preservation of the public peace, health, safety, and property;

NOW, THEREFORE BE IT ORDAINED by the Council of the Village of Sugar Grove, Fairfield County, State of Ohio as follows:

Section 1. The new position of "Sergeant" is created within the Sugar Grove Police Department with an established pay rate of \$10.75 per hour.


Section 2. The effective date of this measure shall be retroactive to August 14, 2017. Any individual promoted to the rank of Sergeant within thirty (30) days of this measure's passage date shall be entitled to back pay to August 14, 2017 at the difference between the Sergeant's rate of \$10,75 and whatever rate of pay they received in the interim working for the Sugar Grove Police Department.

Section 3. This Ordinance is hereby declared to be an emergency measure and is necessary for the immediate preservation of the public peace, health, and safety of the inhabitants of the Village of Sugar Grove; to wit: The necessity for such action arising out of the continued sound fiscal management of the Village's police staff.

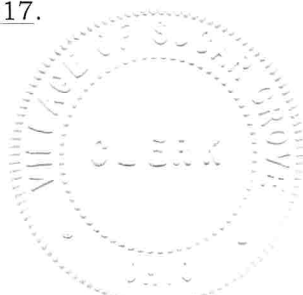
