

**ORDINANCE NO. 6-2017**

**Village of Sugar Grove, Fairfield County, Ohio**

**AN ORDINANCE ADJUSTING AND REDISTRIBUTING THE COMPENSATION OF THE VILLAGE CLERK/FISCAL OFFICER SALARY AND BENEFITS AMONG VARIOUS FUNDS FOR THE VILLAGE OF SUGAR GROVE, FAIRFIELD COUNTY, OHIO AND DECLARING AN EMERGENCY**

**WHEREAS**, The Village Clerk/Fiscal Officer’s job duties encompass substantial efforts within several different departments; and

**WHEREAS**, The Village Council wishes to adjust and redistribute the Village Clerk/Fiscal Officer’s annual salary and benefits among various funds;

**NOW, THEREFORE BE IT ORDAINED** by the Council of the Village of Sugar Grove, Fairfield County, State of Ohio as follows:

**Section 1.** That effective the March, 2017 payroll for the Clerk/Fiscal Officer, annual compensation of salary shall be adjusted and redistributed from funds as follows:

General	1000	47%
Water	5101	21%
Sewer	5201	21%
Sanitation	5601	11%

**Section 2.** That effective the March, 2017 payroll for the Clerk/Fiscal Officer, the employer share of retirement benefit contribution shall be adjusted and redistributed from funds as follows:

General	1000	50%
Streets	2011	25%
Water	5101	25%


**Section 3.** That the Clerk of Council, pursuant to O.R.C. 731.23, shall codify and publish this Ordinance in a manner required by law.

**Section 4.** This Ordinance is hereby declared to be an emergency measure and is necessary for the immediate preservation of the public peace, health, and safety of the inhabitants of the Village of Sugar Grove, the necessity for such action arising out of the continued sound fiscal management of the Village’s financial affairs.


