

ORDINANCE NO. 8-2017

Village of Sugar Grove, Fairfield County, Ohio

AN ORDINANCE ADJUSTING AND REDISTRIBUTING THE COMPENSATION OF THE INTERIM ASSISTANT FISCAL OFFICER, INTERIM ASSISTANT CLERK OF COUNCIL, AND INTERIM ASSISTANT UTILITY CLERK FOR THE VILLAGE OF SUGAR GROVE, FAIRFIELD COUNTY, OHIO; AND DECLARING AN EMERGENCY

WHEREAS, Vicki Westerman has recently been hired as the Interim Assistant Village Fiscal Officer, Interim Assistant Clerk of Council, and Interim Assistant Utility Clerk; and

WHEREAS, the job duties of said positions encompass efforts within several different departments; and

WHEREAS, The Village Council wishes to distribute this position's payment and benefits among several funds; and

WHEREAS, the Mayor recommends the passage of this Ordinance as an emergency measure, as it is necessary for the immediate preservation of the public peace, health, safety, and property;

NOW, THEREFORE BE IT ORDAINED by the Council of the Village of Sugar Grove, Fairfield County, State of Ohio as follows:

Section 1. Effective March 27, 2017, payroll wages for the Interim Assistant Fiscal Officer/Clerk of Council/Utility Clerk shall be distributed from funds as follows:

General:	1000	60%
Sewer:	5201	20%
Sanitation:	5601	20%

Section 2. Effective March 27, 2017, payroll employer share of the state retirement benefits for the Interim Assistant Fiscal Officer/Clerk of Council/Utility Clerk shall be distributed from funds as follows:

General:	1000	50%
Water:	5101	50%


Section 3. That the Clerk of Council, pursuant to ORC 731.23, shall codify and publish this Ordinance in the manner required by law.


