

ORDINANCE NO. 9-2017

Village of Sugar Grove, Fairfield County, Ohio

AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT TO PURCHASE A TRACTOR AND ACCESSORIES, NOT TO EXCEED \$20,000 WITH APPROPRIATIONS FROM THE GENERAL FUND (1000) AND STREETS FUND (2011), AND DECLARING AN EMERGENCY

WHEREAS, Village Maintenance employees and Council have determined that it is imperative to have updated vehicles and equipment to provide the highest level of Village services; and

WHEREAS, Village employees and Council have determined that to provide said services, it is necessary to purchase a tractor and related accessories to be used to provide efficient maintenance of Village buildings, lands, streets, and utilities systems; and

WHEREAS, the Village has investigated several options with respect to obtaining such equipment; and

WHEREAS, the Mayor recommends the passage of this Ordinance as an emergency measure, as it is necessary for the immediate preservation of the public peace, health, safety, and property;

NOW, THEREFORE BE IT ORDAINED by the Council of the Village of Sugar Grove, Fairfield County, State of Ohio as follows:

Section 1. The Mayor is hereby authorized to act on behalf of the Village and enter into a purchase agreement with Specialty Tractors, as "Exhibit A" attached hereto, for the purchase of one (1) new Max 26 XL Tractor with Loader, 60" Mid Mower Deck and Rear 3PT Blade equipment.

Section 2. The equipment shall be used for governmental purposes only.


Section 3. The Fiscal Officer is hereby authorized to reallocate permanent appropriations previously adopted on February 27, 2017 in Ordinance 4-2017 as follows: up to \$15,000 from the General Fund 1000-790-690-0000 "Other" to 1000-800-550-0000 "Motor Vehicles" (Capital Outlay) and up to \$5,000 from the Streets Fund 2011-620-396-0000 "Streets, Highways, Curbs & Sidewalks" to 2011-800-550-0000 "Motor Vehicles" (Capital Outlay) in order to authorize a purchase order and execute a warrant for payment of said equipment.

Section 4. This Ordinance is hereby declared to be an emergency measure and is necessary for the immediate preservation of the public peace, health, and safety of the inhabitants of the Village of Sugar Grove, the necessity for such action arising out of the need for sound maintenance of Village lands, buildings, and utilities systems and the terms of said purchase being favorable and subject to change if purchase is delayed.
