**RESOLUTION TO POST ONE OR MORE SIGNS AT VILLAGE LIMITS ANNOUNCING SUGAR GROVE TO BE "THE HOME OF BOBBY FISHER"**

**NOW THEREFORE, BE IT RESOLVED** by the Council of the Village of Sugar Grove, Fairfield County, Ohio as follows:

**Section 1.** The Village of Sugar Grove does hereby agree to erect one or more signs at the entrance of the Village announcing it to be "The Home of Bobby Fisher."


**Section 2.** The expense for any sign(s) will be provided by a donation from the Fisher family.


