**A RESOLUTION FOR THE INCREASE IN PAY FOR VILLAGE EMPLOYEE TRAVIS GROVES**

**WHEREAS**, Village employee Travis Groves has undertaken significant additional duties in the course of his employment; and

**WHEREAS**, it is necessary to keep valuable employees with a rate of pay commiserate with their work duties; and

**WHEREAS**, the Mayor recommends the passage of this Resolution as an emergency measure, as it is necessary for the immediate preservation of the public peace, health, safety, and property, to wit: maintaining employment standards for employees tasked with maintaining Village infrastructure.

**NOW THEREFORE, BE IT RESOLVED** by the Council of the Village of Sugar Grove, Fairfield County, Ohio as follows:

**Section 1.** Travis Groves is hereby granted a pay raise of \$1.00 per hour.


**Section 2.** Said raise is retroactive to October 1, 2017.



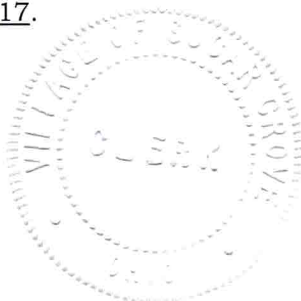
