RESOLUTION TO HIRE VICKI WESTERMAN AS INTERIM ASSISTANT FISCAL OFFICER, INTERIM ASSISTANT CLERK OF COUNCIL, AND INTERIM ASSISTANT UTILITY CLERK FOR THE VILLAGE OF SUGAR GROVE, FAIRFIELD COUNTY, OHIO; AND DECLARING AN EMERGENCY

WHEREAS, Jeremy VanMeter, the Village Fiscal Officer, Clerk of Council, and Utility Clerk, despite a laudable performance in seeking to address matters of concern to the Village of Sugar Grove, realistically needs assistance in addressing these jobs beyond the part-time position the Village has hired him for; and

WHEREAS, Vicki Westerman has expressed willingness to work part-time as an interim assistant to Mr. VanMeter in these roles, to which Council and Mr. VanMeter have expressed support; and

WHEREAS, the Mayor recommends the passage of this Resolution as an emergency measure, as it is necessary for the immediate preservation of the public peace, health, safety, and property;

NOW THEREFORE, BE IT RESOLVED by the Council of the Village of Sugar Grove, Fairfield County, Ohio as follows:

Section 1. he Village of Sugar Grove does hereby agree to hire and provide compensation to Vicki Westerman in the amount of \$20 per hour, with a number of hours to be compensated not to exceed 25 hours per month, for undertaking the duties of Assistant Fiscal Officer, Assistant Clerk of Council, and Assistant Utility Clerk, effective March 27, 2017.

Section 2. This Resolution is hereby declared to be an emergency measure and is necessary for the immediate preservation of the public peace, health, and safety of the inhabitants of the Village of Sugar Grove, the necessity for such action arising out of the continued sound fiscal management of the Village's financial affairs.


