RESOLUTION TO RAISE CONTRACTED MONTHLY RATE AND MAKE CONTRIBUTIONS TO OHIO PUBLIC EMPLOYEES RETIREMENT SYSTEM (OPERS) FOR VILLAGE SOLICITOR AND DECLARING AN EMERGENCY

WHEREAS, the current Village Solicitor has worked a substantial number of hours reasonably deserving of a raise in pay and inclusion in the Ohio Public Employees Retirement System; and

WHEREAS, the Mayor recommends the passage of this Resolution as an emergency measure, as it is necessary for the immediate preservation of the public peace, health, safety, and property;

NOW THEREFORE, BE IT RESOLVED by the Council of the Village of Sugar Grove, Fairfield County, Ohio as follows:

Section 1. The Village of Sugar Grove does hereby agree to raise the monthly pay for the Village Solicitor position to \$420 per month, effective July 1, 2017.


Section 2. The Village further authorizes contributions in the statutorily mandated rate to the Ohio Public Employees Retirement System (OPERS).

Section 3. This Resolution is hereby declared to be an emergency measure and is necessary for the immediate preservation of the public peace, health, and safety of the inhabitants of the Village of Sugar Grove, the necessity for such action arising out of the continued sound fiscal management of the Village's legal affairs.
