The Village of Sugar Grove Council met in Regular Session with Mayor Oatney presiding.

RC: Clark, Hart, Stiles.

Also: Schosek, Springer, B.Primmer, Arter, Heineman, Heston, Edwards.

Floor was opened for nominations to fill vacancies, the Board of Elections threw out 3 petitions of the four wanting to run for re-election. On motion by Stiles to nominate Arter to fill his vacant seat, 2nd Clark. RC: Clark, Stiles Hart yea. Clark moved nominations be closed, 2nd Stiles. RC: Clark, Stiles, Hart yea. Mayor swore in Arter and he took his seat on Council. Floor was opened for nominations for Heineman's seat. On motion by Stiles, 2nd Clark to nominate Heineman. RC: Stiles, Clark, Arter, Hart yea. Mayor swore in Mr. Heineman and he took his seat on Council. Floor was opened for nominations for Heston's seat. On motion by Clark 2nd Stiles to nominate Heston. RC: Clark, Stiles, Arter, Hart, Heineman yea. Clark moved to close nominations, 2nd Stiles. RC: Clark, Stiles, Arter, Hart, Heineman yea. Mayor swore in Heston and she took her seat on Council.

Floor was opened for nominations for Council President Pro-Temp. Hart nominated Stiles, 2nd Heineman. Stiles nominated Arter, 2nd Heston. Clark moved to closed nominations, 2nd Heston. RC: Clark, Heston, Arter, Hart, Heineman, Stiles Yea. Since there were two nominations ballots were cased, Clerk read ballots and Edwards counted as follows: Arter 5; Stiles 1. Arter to serve as Pres.Pro-Tem. for 1998.

On motion by Heston, 2nd Heineman to approve Clerk's Report. RC: Heston, Heineman, Arter, Clark, Hart, Stiles yea

On motion by Heineman, 2nd Heston to dispense with reading of minutes and approve as presented. RC: Heston, Heineman Arter, Clark, Hart, Stiles yea.

On motion by Clark, 2nd Heineman to pass Annual Appropriations Ordinance 28-98. RC: Clark, Heineman, Arter, Hart Heston, Stiles yea.

On motion by Stiles, 2nd Arter to have Clerk pay bills That come in for January. RC: Stiles, Arter, Clark, Hart, Heineman, Heston yea.

On motion by Stiles to approve Mayor's Monthly Report with \$352.00 to Village \$120.00 to State and \$15.00 to BMV. 2nd Heston. RC: Stiles, Heston, Arter, Clark, Hart, Heineman yea.

On motion by Stiles to pay South for the sick time without Drs. slip, and give South a written reprimand, 2nd Hart. After discussion on issue, Stiles moved to withdraw motion, 2nd Hart. Stiles then moved to pay South 19.5 sick hours from PE 12/13/97, 2nd Hart. RC: Stiles yea, Hart yea, Arter no, Clark no, Heineman no, Heston no. Motion defeated 4-2.

Primmer thanked village for prompt response to Sewer Line clog on East St.

On motion by Heston 2nd Heineman meeting adjourned.
