On motion by Stiles, 2nd Arter to approve Clerk's report. RC: Stiles, Arter, Clark, Hart, Heston.

On motion by Heston, 2nd Stiles to approve bills. RC: Heston, Stiles, Arter, Clark, Hart.

Finance Committee gave report. Discussed all full-time employees taking at least 1/2 hr. lunch.

On motion by Stiles, 2nd Heston to approve Mayor's report. RC; Stiles, Heston, Arter, Clark, Hart.
