

Ordinance NO. 10-2018
Village of Sugar Grove, Fairfield County, Ohio

AN ORDINANCE ACCEPTING GRANT REVENUE PROCEEDS FOR THE GRANT CONSTRUCTION FUND (4201) FOR WATER TREATMENT PLANT IMPROVEMENTS AND ADOPTING SUPPLEMENTAL APPROPRIATIONS FOR FY2018, AND DECLARING SAME AN EMERGENCY

WHEREAS, the Village of Sugar Grove has received a grant from the State Community Development Block Grant (CDBG) Program Residential Public Infrastructure Program; and

WHEREAS, all monies collected as part of this grant shall be placed in a separate fund to be known as the "WTP Construction Grant Fund" to be further identified as Fund 4201; and

WHEREAS, the Village is in receipt of the remaining \$109,534 of the \$375,000 grant awarded by the Ohio Development Services Agency; and

WHEREAS, appropriations in supplement to the Village's annual appropriations Ordinance must be made to ensure timely payment to the Village's construction contractor for the Water Treatment plant improvements; and

WHEREAS, the Mayor recommends passage of the legislation as an emergency measure necessary to preserve the public interest, welfare, and peace in order to provide for legitimate expenditures for the year ending December 31, 2018.

NOW THEREFORE, BE IT ORDAINED by the Council of the Village of Sugar Grove, Fairfield County, Ohio as follows:

- Section 1.** That monies deposited in this fund shall be used only for the purposes as established by the terms of the grant agreement (Reference Grant Number C-W-16-2NV-1).
- Section 2.** That the Village, having received \$109,534 from the State of Ohio of the CDBG funds awarded, sets aside and hereby appropriates an additional \$109,534 for Fund 4201 for the Water Treatment Plant construction contractor services as authorized by Council. The total supplemental appropriations for Fund 4201 for FY2018 now total \$375,000.
- Section 3.** That the Village Clerk/Fiscal Officer be and is hereby directed to file a certified copy of this Ordinance with the County Auditor in order to ensure compliance with the Amended Certificate of Estimated Resources available.
- Section 4.** That Council finds and determines that all formal actions of this Council concerning and relating to the passage of this Ordinance were taken in an open meeting of this Council, and that all deliberations of this Council and of any committee that resulted in those formal actions were meetings open to the public in compliance with law.
- Section 5.** That this Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, property, and safety in that funds must be received and expended per grant agreement, wherefore this Ordinance shall be in full force and take effect immediately upon its passage.




